



Release, Waiver, and Indemnity Agreement

IT IS THE INTENTION OF THE PARTICIPANT BY THIS AGREEMENT TO EXEMPT AND RELIEVE FAMILY LIFE FELLOWSHIP AND ITS OFFICERS, AGENTS, SERVANTS, OR EMPLOYEES FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH OF THE PARTICIPANT CAUSED BY ANY ACT OF NEGLIGENCE FAMILY LIFE FELLOWSHIP AND ITS OFFICERS, AGENTS, SERVANTS, OR EMPLOYEES.

For and in consideration of permitting the participant in the city of Moberly, County of Randolph, and State of Missouri, beginning on the day of _____, the undersigned participant: **hereby voluntarily and absolutely release, discharges, waives, and relinquishes any and all loss or damages or actions or causes of action for personal injury, property damage, or wrongful death occurring to the participant as a result of the participant's observing or using facilities or equipment of Family Life Fellowship, or engaging in or receiving instructions in any activities SOME OF WHICH MAY INVOLVE DANGER AND RISK OF BODILY INJURY or in activities incidental thereto wherever or however the same may occur, and for whatever period said activities or instructions may continue.**

The undersigned participant for him/herself, his/her heirs, executors, administrators, or assigns agrees that in the event any claim for personal injury, property damage, or wrongful death shall be prosecuted against Family Life Fellowship or its officers, agents, servants, or employees, the undersigned parent or guardian **will indemnify and hold harmless Family Life Fellowship and its officers, agents, servants, or employees** from any and all claims or causes of action by the participant or by any other person or entity, by whomever or wherever made or presented, and **under no circumstances will the undersigned participant present any claim against Family Life Fellowship and said persons for personal injuries, property damage, wrongful death, or otherwise, caused by any act of negligence by Family Life Fellowship and said persons.**

The undersigned person represent that he/she has read this Release, has requested and has been provided with, or has requested and declined advisement on the potential dangers/risks of engaging in the observation, activities, or instruction offered, **assumes all risks associated with such dangers and risks**, and is fully aware of and understands the terms and the legal consequences of the signing of this Release. The undersigned parent or legal guardian intends his or her signature to be a complete and unconditional release of all liability to the greatest extent allowed by law and if any portion of the Release is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
